Invocation and Pledge of Allegiance

LJ led the invocation and Pledge of Allegiance, then called the meeting to order at 6:00 PM.

Approval of Agenda

DA motioned to approve the agenda. JC seconded. Vote: All in favor. Motion carried.

Public Comment

- No public comments were offered.

EMERGENCY BUSINESS

- **Discussion and possible action regarding council authority and process for addressing council member conduct; potential referral to the Governor under §112.51, F.S., concerning Council Member Mixon.**

Town Clerk Ben Tew reviewed the legal provisions outlined in the agenda materials, explaining that under Florida Statute §112.51, only the Governor has authority to suspend or remove an elected municipal officer for cause, and that the Council may only make a referral or adopt a statement of concern.

Discussion followed regarding Council Member Mixon's conduct and the Town Council's options under the statute.

Council Member Daniel Arrant moved that the Town of Noma request the Governor of Florida to review the conduct of Council Member Coy Mixon under §112.51, F.S., and consider removal. Council Member Josephine Curry seconded the motion.
